## **2025 Approved CFHLA Legislative Priorities**

As state lawmakers prepare to meet in Tallahassee, CFHLA is proud to share our <u>2025 approved CFHLA Legislative Priorities</u>. The CFHLA Board of Directors approved this list of nine top priorities during its January Board of Directors Meeting on January 22nd.

#### **Tourist Development Tax (TDT)**

The proper reinvestment and **appropriate use of TDT will drive further visitation to our destination** and continue to benefit our local economy and residents through increased jobs and wages, sales tax revenue, property tax, etc. CFHLA **strongly opposes adding any new or expanded uses for Tourist Development Tax (TDT) revenues**.

#### **VISIT FLORIDA Funding**

CFHLA **supports the continued annual recurring funding of VISIT FLORIDA.** Funding of <u>VISIT FLORIDA</u> ensures that our state continues to be top of mind as the leading vacation destination in the country.

# Increased Funding for Transportation and Infrastructure Projects

CFHLA supports the **increased funding of essential transportation and infrastructure projects** across the Central Florida region (excluding using TDT funds).

# Additional Education Funding for Hospitality/Culinary Programs at our Local Schools, Colleges, and Universities

CFHLA supports additional funding for our hospitality and culinary programs at our local high schools, as well as the increased perstudent funding at <u>Valencia College</u>, <u>Seminole State College</u>, and the <u>University of Central Florida</u>.



## **Workforce Housing**

**CFHLA supports the continued full funding for the Sadowski Fund,** as the Central Florida community has a dire need for more reliable and affordable housing options.

# **Commercial Property Insurance Reform**

CFHLA supports any legislative efforts that are aimed at **reducing the cost of commercial insurance in Florida**.

#### Statewide Regulation of Vacation Rentals and Advertising Platforms

CFHLA strongly supports requiring initiatives that ensure vacation home rentals on advertising platforms also practice the same safety standards as traditional lodging to protect visitors and their experience.

## **Timeshare Revisions**

**CFHLA supports both of <u>ARDA</u>'s legislative proposals**, including making timeshare-specific changes to the provisions passed in two condo/HOA bills passed during the 2024 Florida Legislative Session (HB 1021 and HB 1203).

#### Interchange Fees on Sales Tax

CFHLA supports **prohibiting the collection of interchange on sales tax**, which will provide relief to businesses, which will in turn provide relief to consumers.

# Florida Lawmakers and Gov. Ron DeSantis Disagree on Bills to Address Illegal Immigration

Gov. Ron DeSantis and leaders of the Florida Legislature are locked in a strong disagreement over the best ways to address immigration enforcement in Florida. This week, Governor DeSantis is threatening to veto the Legislature's newest bill after lawmakers on Monday cancelled the Legislative Special Session he called for, in order to pursue their own bills to address illegal immigration.

Lawmakers in the House and Senate passed their \$500 million bill Tuesday night after getting input from the Trump Administration on how to draft it.

House and Senate leaders get to decide when they will send their bill to Governor DeSantis, and he will have 14 days to veto it or sign it into law.

The Legislature's bill increases penalties for unauthorized aliens who use false ID to vote, provides funding for local law enforcement to provide training and help federal immigration officials and allows the leasing of jails and state prisons to hold detainees, among other things. The legislation also includes a mandatory death penalty for illegal immigrants convicted of murder or the rape of a child, enhanced criminal penalties for undocumented immigrants who have been deported and then return to Florida to commit a crime, and enhanced sentencing for unauthorized immigrant gang members. The bill names the Commissioner of Agriculture as the state's chief immigration enforcement officer.

The focus on immigration reform is especially important to the Central Florida Hotel & Lodging Association. Two years ago, the Legislature considered legislation that would have made sweeping changes to Florida's immigration enforcement, including items like providing transportation to an undocumented immigrant within the state. CFHLA leadership and our allies were successful in amending that language. We are closely monitoring how any new legislation regarding illegal immigration may impact our hospitality and tourism industry.

Advocacy – CFHLA encourages our members and partners to get involved with the legislative process before and during the special legislative session. We encourage you to reach out to our state lawmakers to ask that the special session legislation do no harm to our hospitality and tourism industry in Florida.



# Governor Ron DeSantis Appoints FL Attorney General Ashley Moody to Replace Rubio in U.S. Senate

Governor Ron DeSantis is now working with a close ally in Washington, DC after appointing Florida Attorney General Ashley Moody to replace Marco Rubio in the United States Senate. Moody has served as the state's top legal officer since 2019. Governor DeSantis made the announcement last week at the Rosen Plaza Hotel in Orlando. Moody was sworn-in to the U.S. Senate last week. Rubio is now serving as U.S. Secretary of State under President Donald Trump.

Moody has a "demonstrated record of delivering results" and carrying out the Republican agenda on issues such as immigration and voter fraud, DeSantis said at the news conference to announce her appointment. "She has stood strong time and time again," DeSantis said. **James Uthmeier, DeSantis'** chief of staff, will take Moody's place as Florida Attorney General.

Moody is a fifth-generation Plant City resident and a former federal prosecutor who in 2006 became the youngest state circuit court judge when she was appointed to the **13th Circuit in Hillsborough County**.

"America First!" Moody said after DeSantis introduced her. "Let's get it done." "Every day I go to work, every decision that I make, every person I hire, I do so with the understanding that the people of Florida gave me this opportunity, and I want to deliver on what I assured them," Moody said. "I believe that we have done that, and I think we have to take that same direction to the United States Senate."

Moody adds she will work to protect residents' and communities' rights and the "autonomy" of the state.
